

# Home-based OSCAR Approval Application Form

## Level 3

#### Introduction

Use this form to apply for approval to deliver home-based Out of School Care and Recreation (OSCAR) programmes.

The form can be used for new applications for programmes not already approved, and programmes already approved that need their approval reviewed.

Te Kāhui Kāhu are responsible for approving OSCAR programmes, under <u>sections 45-47 of the Social</u> Security Regulations 2018. Te Kāhui Kāhu will:

- use the information provided on the form, along with the required supporting documentation, to assess whether approval may be granted, and
- only grant approval for providers already licensed by the Ministry of Education (MOE) to deliver home-based early childhood education (ECE) and care services.

Although a site visit isn't usually required, Te Kāhui Kāhu may conduct a site visit to clarify information or respond to concerns.

We only approve home-based OSCAR programmes that:

- are for children aged five to 13 years of age, enrolled and attending school, and
- operate between the hours of 6:30am-7:00pm.

If you submit the application without supporting documentation, we will inform you that it is incomplete. You will have 20 working days to submit any outstanding documentation before the application is declined.

Note: The maximum number of children in a licensed home-based service will be six, of which no more than four children can be using the service for ECE. The age limit for children who can receive OSCAR is 13 years.
